#### Why do we exist?

	Objective 9 – To conduct a review of our communications and engagement activities, and develop a plan to ensure our activities align with our strategic objectives.

- Follow up on our research and recommendations from 2024/2025 to demonstrate the impact of our work.
- Continuously share real time, patient experiences with commissioners and providers across the Tameside locality.
